## WATER SHARING AGREEMENT

## RECITALS

WHEREAS, the Lot 1 Parties are now the owner of property known as 11415 W County Road 190, City of Salida, County of Chaffee, State of Colorado, which property is more fully described as follows:

(the "Lot 1 Parcel");

WHEREAS, the Lot 7 Party is the owner of property known as 11417 County Road 190 W, City of Salida, County of Chaffee, State of Colorado, which property is more fully described as follows:

Lot 7

Peak View Subdivision, Reception No. 482816

(the "Lot 7 Parcel");

WHEREAS, the Lot 1 Parcel and the Lot 7 Parcel share three (3) shares of the Sunnyside Ditch Company (the "Water Shares"); and

WHERAS, the parties desire to memorialize their agreement to share the Water Shares and set forth a schedule for use of the Water Shares between them.

NOW, THEREFORE, in consideration of the foregoing and the mutual promises and covenants contained herein, the parties agree as follows:

- 1. The Lot 1 Parties shall be entitled to use of 1.5 shares of the Water Shares for permitted uses in connection with ownership of the Lot 1 Parcel.
- 2. The Lot 7 Party shall be entitled to use of 1.5 shares of the Water Shares for permitted uses in connection with ownership of the Lot 7 Parcel.
- 3. The Lot 1 Parties shall be entitled to use all 3 shares of the Water Shares for the period beginning every Sunday at 7:01 am (local time) through every Wednesday at 7:00 pm (local time).

- 4. The Lot 7 Parties shall be entitled to use all 3 shares of the Water Shares for the period beginning every Wednesday at 7:01 pm (local time) through every Sunday at 7:00 am (local time).
- 5. This Agreement shall be subject to all existing agreements, rules and regulations, and contracts governing use of the Water Shares, including without limitation any rules of the Sunnyside Ditch Company, Chaffee County, and the Colorado Division of Water Resources.
- 6. Only those parcels of real estate hereinabove described, and the dwellings located thereon shall be permitted to receive water from the Water Shares; and each of the parties hereto does hereby covenant and agree that he/she will not allow or permit other persons, other than household guests, to take, draw, use or receive water from the Water Shares, nor permit other persons to connect to the pipes or mains serving their respective parcel.
