

Know All Men By These Presents: That Bryan Harrison, joined by his wife Mary M. Harrison, has caused to be made the attached plat entitled "SHERWOOD FOREST" the same being the SW 1/4 of the NE 1/4 of Section 26, Township 2 South, Range 13 East, Subject to the right-of-way of State Road 50, and EXCEPTING the parcel of land hereinafter described, SUBJECT to the roadway as recorded in Deed Book 78, Page 114, Suwannee County, Florida, Public Records, Line One, Florida.

EXCEPTION: Begin at a point on the accepted line dividing the SW 1/4 of the NE 1/4 and the NW 1/4 of the NE 1/4 of Section 26, Township 2 South, Range 13 East, where said line intersects the East side of Darrow Street, and run East along said accepted line 350 feet to the point of beginning; thence East along said accepted line 175 feet; thence South 160.6 feet; thence West 160 feet; thence along the arc of a 25-foot radius curve to a point 130.6 feet South of the point of beginning; thence North 130.6 to the point of beginning.

ADOPTION (DEDICATION) This plat certifies that the undersigned, as lawful owners of the lands herein described, and that we have caused the same to be surveyed and subdivided, and this plat made in accordance with said survey is hereby adopted as the true and correct plat of said lands, and all Streets, Roads and other Public Places shown upon said plat are hereby proposed and without reservation dedicated to the County of Suwannee, State of Florida, and its Successors. 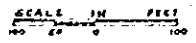
