AMENDMENT TO RESTRICTIVE COVENANTS

The undersigned, being one or more of the owners of a lot or lots identified underneath their names which are located in Sherwood Forest, a subdivision according to plat thereof, recorded in Plat Book 1, page 51, public records, Suwannee County, Florida, (herein "Sherwood Forest") hereby agree that the restrictive covenants with respect to Sherwood Forest, as hereafter described, shall be and are hereby amended as hereafter provided, effective from and after the 1st day of January, 2005, as follows:

shall be and is hereby released and discharged from all and singular, the terms, conditions and covenants of the Restrictive Covenants as recorded in Deed Book 80, page 420, public records, Suwannee County, Florida, (herein "the Covenants") including without limitation, each and every of the Covenants which limits use of the above described lots solely for residential purposes.

2. The above described lot shall not be restricted in any way in the future by any provisions of the Covenants, including any setback restrictions or otherwise, as provided therein, and each and every one of the Covenants are hereby declared to be null, void and of no further force and effect insofar as they pertain to the above described lot. The undersigned specifically consent to the use of the above described lots for any lawful commercial or business activity or purpose, provided that such use shall be in accordance with applicable zoning ordinances and land use regulations of the City of Live Oak, Florida.

3. The undersigned further consent to the future use of all or any portion of the above described lot for a public or private road, thoroughfare, parking lot, right-of-way, street, alley, or other use for ingress, egress and utilities.

4. Except as amended and modified hereby, all other terms of the Covenants shall be and remain in full force and effect as to all remaining lots within Sherwood Forest not released hereby.
