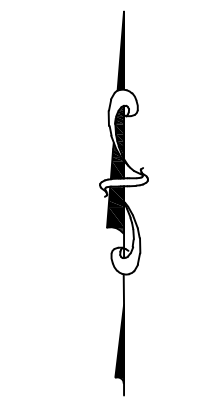
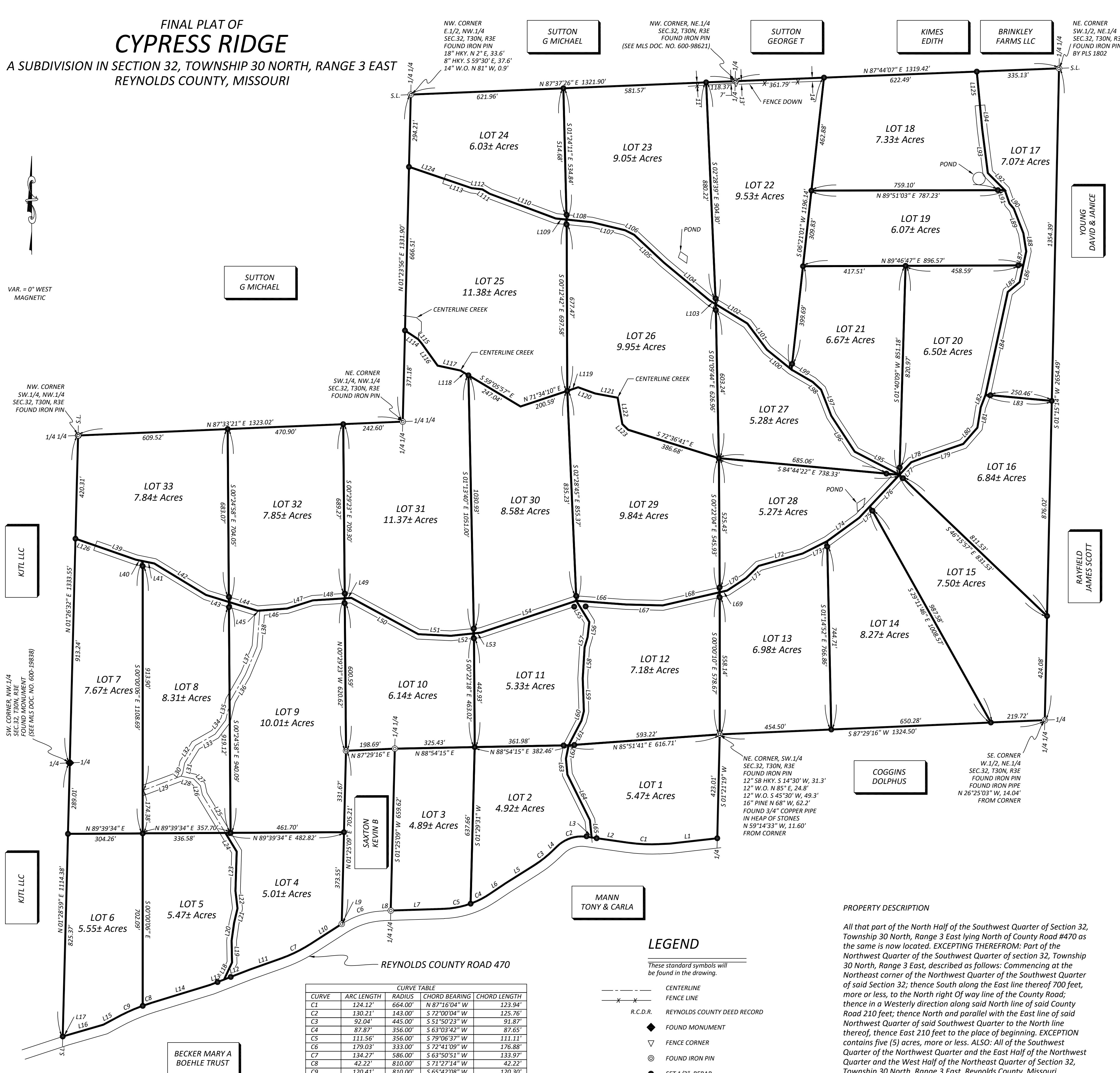


FINAL PLAT OF

PROPERTY DESCRIPTION

All that part of the North Half of the Southwest Quarter of Section 32, Township 30 North, Range 3 East lying North of County Road #470 as the same is now located. EXCEPTING THEREFROM: Part of the Northwest Quarter of the Southwest Quarter of section 32, Township 30 North, Range 3 East, described as follows: Commencing at the Northeast corner of the Northwest Quarter of the Southwest Quarter of said Section 32; thence South along the East line thereof 700 feet, more or less, to the North right Of way line of the County Road; thence in a Westerly direction along said North line of said County Road 210 feet; thence North and parallel with the East line of said Northwest Quarter of said Southwest Quarter to the North line thereof, thence East 210 feet to the place of beginning. EXCEPTION contains five (5) acres, more or less. ALSO: All of the Southwest Quarter of the Northwest Quarter and the East Half of the Northwest Quarter and the West Half of the Northeast Quarter of Section 32, Township 30 North, Range 3 East, Reynolds County, Missouri.

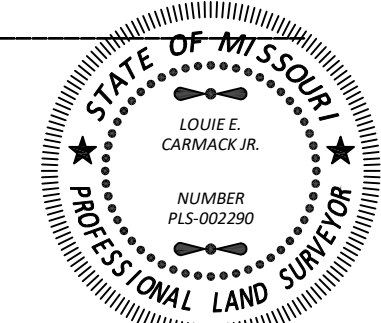

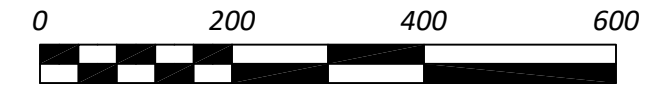
